

LAST WILL AND TESTAMENT OF

IDA J. SMALL

I, Ida J. Small, a resident of St. Charles in the County of Winona and State of Minnesota, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking all prior wills made by me.

I.

I direct my executor hereinafter named to pay all of my just debts, expenses of last illness and funeral expenses as soon after my decease as conveniently may be done.

II.

I give and bequeath to my seven living children, to-wit: Ruby Harcoy, Grace Barr, Minnie Ratsch, Bernard Small, Evelyn Hemming, Kermit Small and Lorna Small, all of my household goods and household effects in equal undivided shares, each one-seventh (1/7) thereof.

III.

I give, devise and bequeath to Harold Pfell an undivided one-third (1/3) interest in and to all the rest, residue and remainder of my estate, both real and personal, not for his own use but in trust for my two children Kermit Small and Lorna Small, for the equal benefit of the said two children. I give and grant unto my trustee the power to pay over to the said children in equal shares the income arising from the corpus of said trust, and I grant unto the said trustee the power to pay over such amounts from the corpus of the trust as may be necessary for the support and maintenance of the beneficiaries in the sole discretion of the trustee. I further grant unto the said trustee the power to terminate the said trust as to either or both of the said beneficiaries at any time that he may in his discretion deem it to the best advantage of such beneficiary, and at such time to pay over to such beneficiary his or her proportionate share of the property in such trust. I further grant unto the said trustee the power to invest and re-invest the funds in said trust from time to time without leave or license of the Court.

V.

I hereby nominate and appoint Ralph G. Harcey to be the executor of this my Last Will and Testament, and I hereby grant unto my said executor the power to sell any of the real estate or personal property in my estate without leave or license of the Court.
